Information: We will weigh wrestlers in each Thursday starting at 6:00. Wrestling will begin approximately at 6:30 p.m. No team score will be kept. Each wrestler will get two matches each night. Matches will be based off of skill level when pairing them up. We will try and keep matches within 10 pounds or less. We will be going with 2-1-1 periods. If time permits, you may get an extra exhibition match. Walk-ins will be accepted. The cost is \$10 a night, but you must have a signed waiver. No T shirt will be given to walk-ins unless you pre order one.
